
# Choosing to continue working for the same employer when the employment period ends

Before signing a new labor contract pay close attention to the following:

- Carefully consider whether you want to continue the contract
- Make sure there are no mistakes or omissions in the details of the contract.

Based on the spirit of the contract, once signed both sides are obligated to observe the provisions contained therein.

In the event there is a dispute during the period for which the contract is valid call the 1955 Hotline.



# Masa Kontrak Kerja Berakhir

## Memilih melanjutkan bekerja di majikan yang sama

Sebelum menandatangani kontrak kerja baru  
Anda diingatkan untuk memperhatikan berikut ini :

- Mempertimbangkan dengan baik-baik,  
apakah Anda ingin melanjutkan kontrak kerja?
- Memastikan bahwa tidak ada kesalahan  
dalam isi kontrak kerja

Kontrak kerja berbasis kebebasan, kedua belah pihak wajib  
mematuhi isi kontrak kerja yang telah ditandatangani

# Hết hạn hợp đồng lao động

- Xác nhận nội dung của hợp đồng có chính xác hay

hai bên cần tuân thủ các nội dung đã thỏa thuận.
